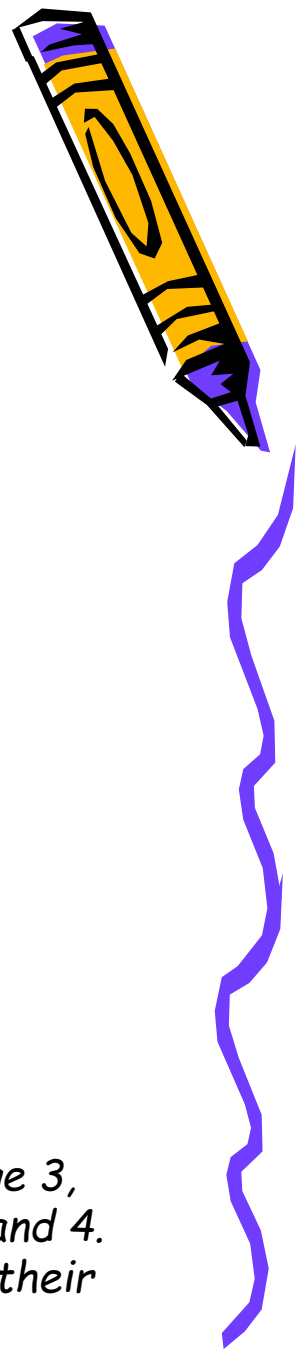
Nursery expectations

On starting Nursery, I will:

1. Go to the toilet, flush the chain and wash my hands independently.

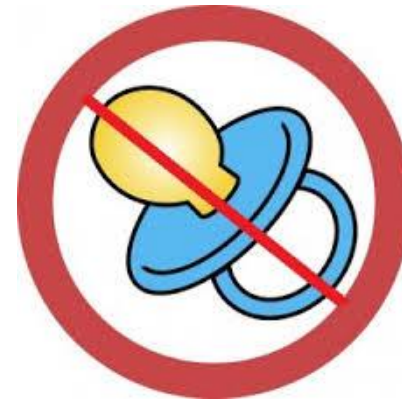


Most children are toilet trained (through the day) by age 3, becoming dry through the night between the ages of 3 and 4. They should also be able to wipe themselves and pull up their own pants.



2. Leave my dummy at home.

Health professionals recommend that by age 3 children should no longer be using a dummy, sucking a thumb or drinking from a bottle. They recommend children drink from a cup. Continued use of dummies/ bottles or thumb sucking can and does affect children's speech development.



3. Put my coat on and take my coat off independently



Zips may be easier and quicker for young children to manage.



4. I can put my shoes on and take them off.

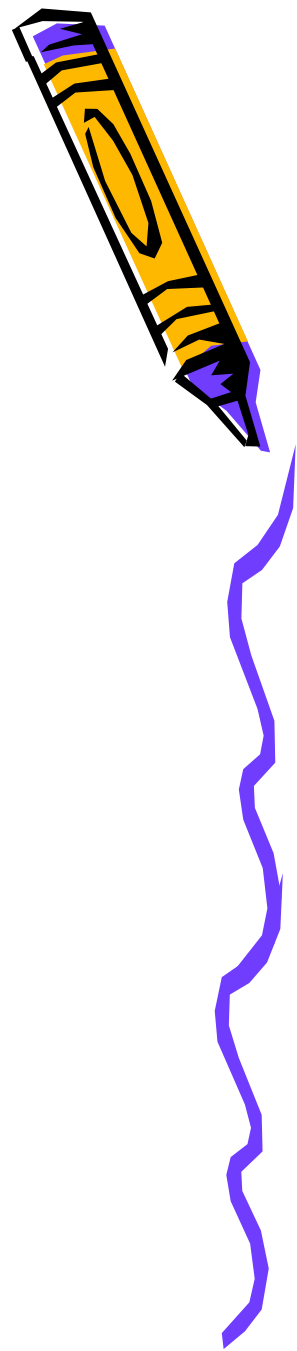


Choose shoes that slip on or fasten with Velcro rather than laces as these are often easier for children to manage on their own.

5. I can drink from a cup



Let your child practice drinking from a cup without a lid, only pour small amounts at a time to avoid spills.

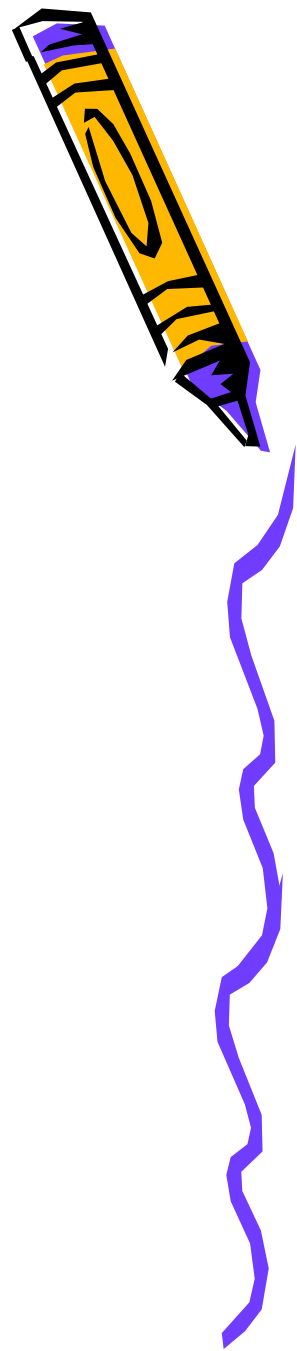


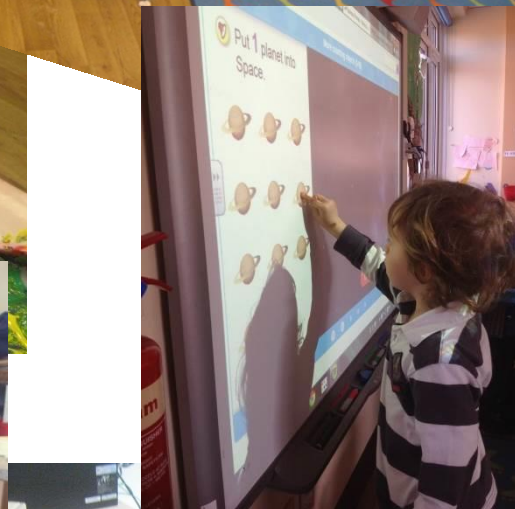
6. I can blow my own **nose** and then put the tissue **in the bin**.

Show your child how to blow and wipe their nose, throw the tissue in the bin



7. I will always show **kind hands and kind feet** to my teachers and peers





Personal, Social and Emotional Development

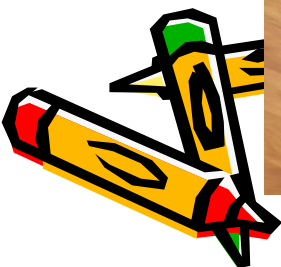


The children will be learning to:

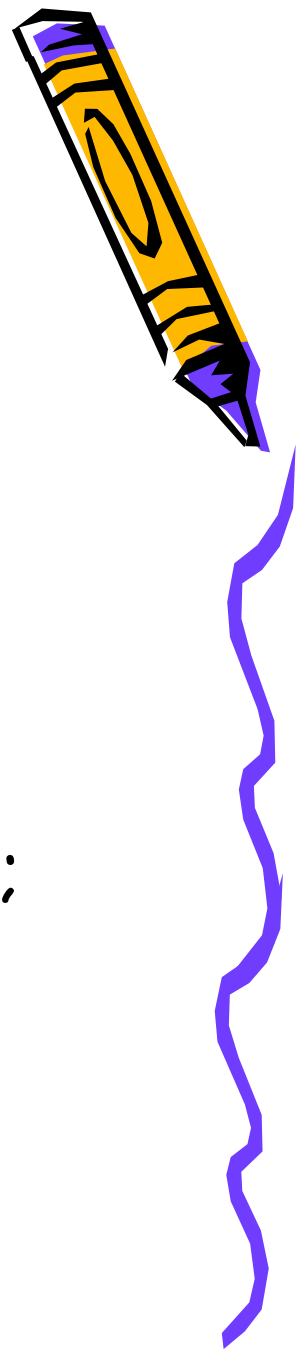


- become self-confident;

- answer questions about stories

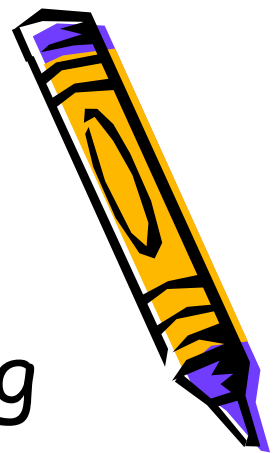
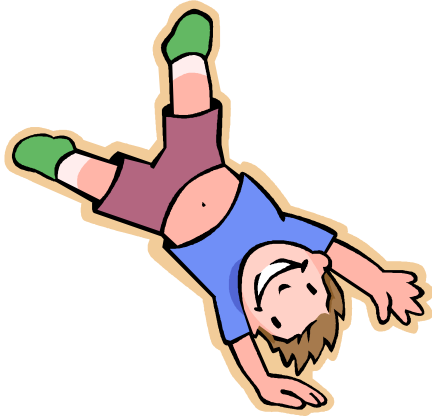


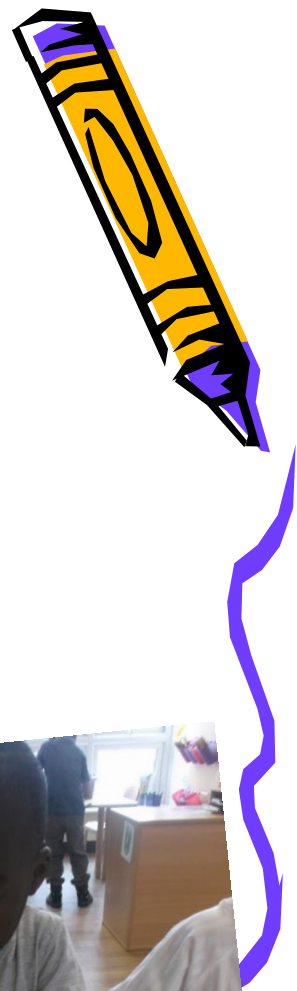


Physical Development

- manage their own basic hygiene and personal needs including dressing and undressing independently.

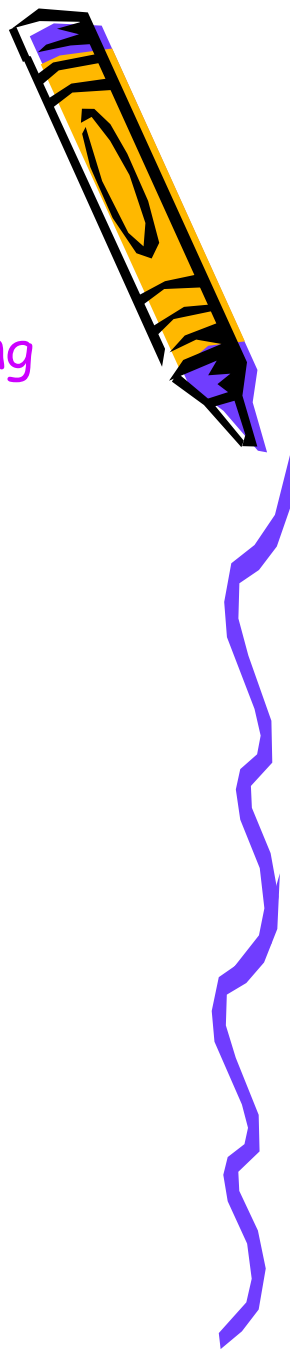




Nursery Staffing

Each Nursery has:

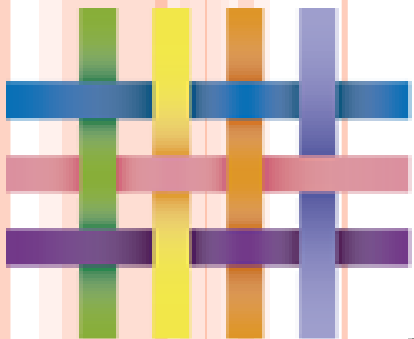
- ✓ A qualified teacher, a qualified nursery nurse and a teaching assistant per nursery class.

Following Progress

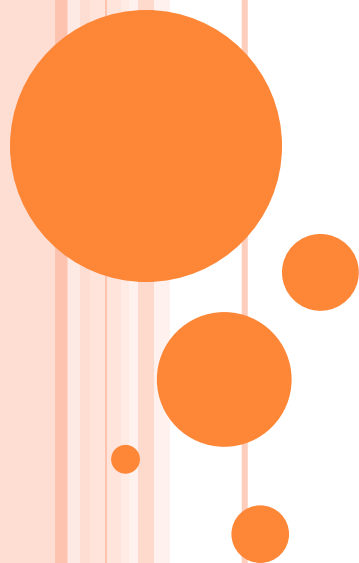
- Every child is assessed daily through their adult led work, child initiated play and through focussed observations.

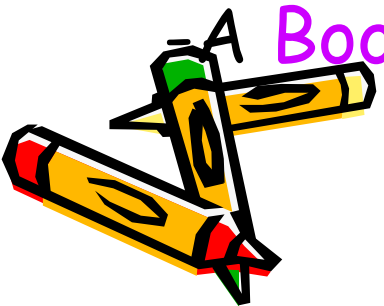
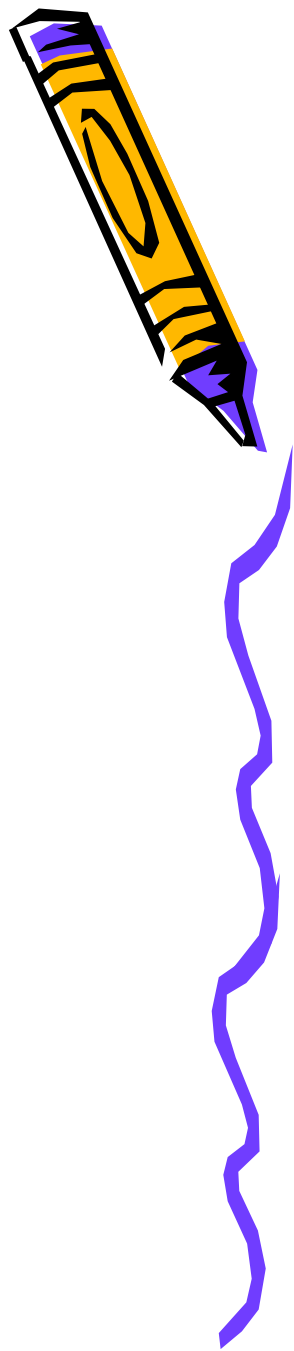

- A Book bag



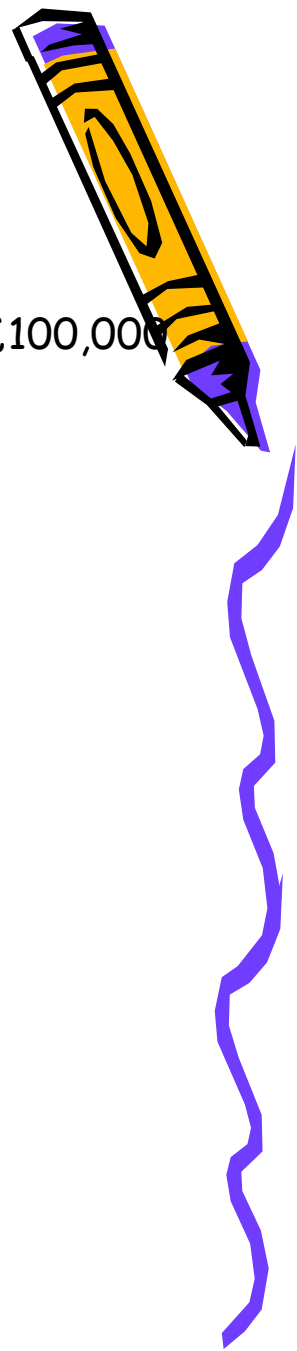
Nursery parent expectations

- Please arrive and collect your child **on time:**
8.30am-11.30am
12.30pm-3.30pm
- Make sure your child has eaten a good **breakfast or lunch** before Nursery.
- Make sure your child has had a full nights sleep. 7pm bedtime is advised by professionals.
- Make sure we know who is **collecting** your child.



Full Time places and Lunch Club

- **30 Hours Funded places to support working parents**
- Eligibility Criteria - parents earning at least 16 hours and earning up to £100,000
- FT = Monday - Friday 8:30 - 3:30
- Includes Lunch Club charged at £8.50 per session
- **FT paid places for 3 year olds**
- £25 per session - includes Lunch Club for 3 year olds
- **PT paid places for 2 year olds**
- £25 per session - no Lunch Club
- **Lunch Club - 11:30 - 12:30**
- Healthy cooked meal - food taster day **Friday 5th July @ 9am**
- Flexible extended provision - can select days

Parent Funding Authorisation Form

Disability Access Fund (DAF)
